I agree on behalf of myself, my heirs, executors, personal representatives, and assigns not to hold the King of Prussia Ski Club, Inc., its officers, board members, members (including but not limited to, the event organizer[s] or participants [collectively "KOPSC"]) liable for any accident, injury, illness, or any loss resulting from my participation. I am executing this Release knowingly, voluntarily, and without reservation.

This Release shall be governed by and construed in accordance with the laws of the Commonwealth of Pennsylvania, without giving effect to conflicts of law principles. For any cause of action against KOPSC resulting from participation in the above referenced event, the parties hereto on behalf of themselves, their heirs, executors, personal representatives, and assigns irrevocably consent to the jurisdiction and venue of the courts of the Commonwealth of Pennsylvania located in Montgomery County, Pennsylvania, and of the United States District Court for the Eastern District of Pennsylvania. No action, regardless of form, arising out of the above referenced event shall be brought more than one (1) year after the cause of action has accrued.

I understand that KOPSC routinely takes photographs of its members engaged in meetings and activities and uses them for various purposes, including, but not limited to, publication in its monthly newsletter, its website, and/or other promotional media.
